<p>1. Purpose</p>	<p style="text-align: center;">815. ACCEPTABLE USE OF COMMUNICATIONS AND INFORMATION SYSTEMS</p> <p>The Northern Westmoreland Career & Technology Center (“CTC”) provides employees, students, and guests (“users”) with access to the CTC’s electronic communication systems and network, which includes internet access, whether wired, wireless, cellular, virtual, cloud or by any other means. Guests include, but are not limited to, visitors, workshop attendees, volunteers, independent contractors, adult education staff, students, Joint Operating Committee members, vendors, and CTC consultants.</p> <p>Computers, network, Internet, Intranet, Electronic Communications and information systems, databases, files, software, and media, collectively called “CIS systems” provide vast, diverse and unique resources. The Joint Operating Committee will provide access to the CTC’s CIS systems for users if there is a specific CTC-related purpose to access information and research; to collaborate; to facilitate learning and teaching; and to foster the educational purpose and mission of the CTC.</p> <p>For users, the CTC’s CIS systems must be used for educational purposes and/or performance of CTC job duties in compliance with this policy. <i>Incidental personal use</i> of CTC computers as defined in this policy is permitted for employees. However, they should have no expectation of privacy in anything they create, store, send, receive, or display on or over the CTC’s CIS systems, including their personal files, or any of their use. Students may only use the CIS systems for educational purposes.</p> <p>CIS systems may include CTC computers which are located or installed on CTC property, at CTC events, connected to the CTC’s network and/or systems, or when using its mobile computing equipment, telecommunication facilities in protected and unprotected areas or environments, directly from home, or indirectly through another Internet Service Provider (“ISP”), and if relevant, when users bring and use their own personal computers or personal electronic devices, and if relevant, when users bring and use another entity’s computer or electronic devices to a CTC location, event, or connect to a CTC network.</p>

Sec. 4603</p>	<p>If users bring personal computers or personal technology devices onto the CTC’s property, to CTC events, or connect them to the CTC’s network and systems, and if the CTC reasonably believes the personal computers and/or personal electronic devices contain CTC information or contain information that violates a CTC policy or administrative regulation, the legal rights of the CTC or another person, or involves significant harm to the CTC or another person, or involves a criminal activity, the personal computers or personal electronic devices may be accessed <i>in accordance with the law</i> to insure compliance with this policy, other CTC policies, regulations, rules, procedures, ISP terms, and local, state and federal laws. Users may not use their personal computers and personal technology devices to access the CTC’s intranet, internet or any other CIS system unless approved by the Administrative Director, and/or designee.</p> <p>The CTC intends to strictly protect its CIS systems against numerous outside and internal risks and vulnerabilities. Users are important and critical players in protecting these CTC assets and in lessening the risks that can destroy these important and critical assets. Consequently, users are required to fully comply with this policy, and to immediately report any violations or suspicious activities to the Administrative Director. Conduct otherwise will result in actions further described in the Consequences for Inappropriate, Unauthorized and Illegal Use Section found at the end of this policy, and provided in relevant CTC policies, regulations, rules</p> <p>Child Pornography – Under federal law, any visual depiction, including any photograph, film, video, picture, or computer or computer-generated image or picture, whether made or produced by electronic, mechanical, or other means, of sexually explicit conduct, where:</p> <ol style="list-style-type: none"> 1. The production of such visual depiction involves the use of a minor engaging in sexually explicit conduct; 2. Such visual depiction is a digital image, computer image, or computer-generated image that is, or is indistinguishable from, that of a minor engaging in sexually explicit conduct; or 3. Such visual depiction has been created, adapted, or modified to appear that an identifiable minor is engaging in sexually explicit conduct. <p>Under Pennsylvania law, any person who intentionally views or knowingly possesses or controls any book, magazine, pamphlet, slide, photograph, film, videotape, computer depiction or other material depicting a child under the age of eighteen (18) years engaging in a prohibited sexual act or in the simulation of such act is guilty of a felony of the third degree for their first offense, or guilty of a felony of the second degree for a second offense.</p>

Sec. 4604</p>	<p>does not include mere words.</p> <p>Access to the CTC’s CIS systems through school resources is a privilege, not a right. These, as well as the user accounts and information, are the property of the CTC, which reserves the right to deny access to prevent further unauthorized, inappropriate or illegal activity, and may revoke those privileges and/or administer appropriate disciplinary action. The CTC will cooperate to the extent legally required with ISP, local, state and federal officials in any investigation concerning or related to the misuse of the CIS systems.</p> <p>It is often necessary to access user accounts in order to perform routine maintenance and security tasks. System administrators have the right to access by interception, and the stored communication of user accounts for any reason in order to uphold this policy, administrative regulations, the law and to maintain the system. Users have no privacy expectation in the contents of their personal files or any of their use of the CTC’s CIS systems. Users should have no privacy expectation in the contents of their personal files or any of their use of the CTC’s CIS systems. USERS SHOULD HAVE NO EXPECTATION OF PRIVACY IN ANYTHING THEY CREATE, STORE, SEND, RECEIVE, OR DISPLAY ON OR OVER THE CTC’S CIS SYSTEMS, INCLUDING THEIR PERSONAL FILES OR ANY OF THEIR USE OF THE CTC’S CIS SYSTEMS. The CTC reserves the right to record, check, receive, monitor, track, log access and otherwise inspect any or all CIS systems use and to monitor and allocate fileserver space. Users of the CTC’s CIS systems who transmit or receive communications and information shall be deemed to have consented to having the content of any such communications recorded, checked, received, monitored, tracked, logged, accessed, and otherwise inspected or used by the CTC, and to the CTC monitoring and allocating fileserver space. Passwords and message delete functions do not restrict the CTC’s ability or right to access such communications or information.</p>

Specifically, the CTC operates and enforces technology protection measure(s) that block or filter online activities of minors on its computers used and accessible to adults and students so as to filter or block inappropriate matter on the internet. Measures designed to restrict adults’ and minors’ access to material harmful to minors may be disabled to enable an adult or student (who has provided written consent from a parent or guardian) to access <i>bona fide</i> research, not within the prohibitions of this policy, or for another lawful purpose. No person may have access to material that is illegal under federal or state law.</p>

	<p>The CTC has the right, but not the duty, to inspect, review, or retain electronic communication created, sent, displayed, received or stored on and over <i>the CTC's</i> CIS systems and to monitor, record, check, track, log, access or otherwise inspect its CIS systems.</p> <p>In addition, <i>in accordance with the law</i>, the CTC has the right, but not the duty, to inspect, review, or retain electronic communications created sent, displayed, received, or stored <i>on user's</i> personal computers, electronic devices, networks, internet, electronic communications systems, and in databases, files, software, and media that contain CTC information and/or data.</p> <p>Also, <i>in accordance with the law</i>, the CTC has the right, but not the duty, to inspect, review, or retain electronic communication created, sent, displayed, received or stored <i>on another entity's</i> computer or electronic device when users bring and use another entity's computer or electronic device to a CTC location, event, or connect it to the CTC network and/or systems, and/or that contains CTC programs, or CTC data or information.</p> <p>The above applies no matter where the use occurs whether brought onto CTC property, to CTC events, or connected to the CTC network, or when using mobile commuting equipment and telecommunications facilities in unprotected areas or environments, directly from home, or indirectly through another social media or internet service provider, as well as by other means. All actions must be conducted pursuant to the law, assist in the protection of the CTC's resources, insure compliance with this Policy, its administrative regulations, or other CTC policies, regulations, rules, and procedures, social media and internet service providers terms, or local, state, and federal laws.</p> <p>The CTC will cooperate to the extent legally required with social media sites, internet service providers, local, state, and federal officials in investigations or with other legal requests, whether criminal or civil actions.</p> <p>The CTC reserves the right to restrict or limit usage of lower priority CIS systems and computer uses when network and computing requirements exceed available capacity according to the following priorities:</p> <ol style="list-style-type: none">1. <u>Highest</u> – uses that directly supports the education of the students.2. <u>Medium</u> – uses that indirectly benefit the education of the students.3. <u>Lowest</u> – uses that include reasonable and limited educationally-related interpersonal communications and employee limited incidental personal use.4. <u>Forbidden</u> – all activities in violation of this policy, other CTC

Responsibility</p>	<p>policies, regulations, rules, procedures, ISP terms, and local, state, or federal law.</p> <p>The CTC additionally reserves the right to:</p> <ol style="list-style-type: none"> 1. Determine which CIS systems' services will be provided through CTC resources. 2. Determine the types of files that may be stored on CTC file servers and Computers. 3. View and monitor network traffic, file server space, processor, and system utilization, and all applications provided through the network and communications systems, including e-mail, text messages, and other electronic communications. 4. Remove excess e-mail and other electronic communications or files taking up an inordinate amount of fileserver disk space after a reasonable time. 5. Revoke User privileges, remove User accounts, or refer to legal authorities, and/or CTC authorities when violation of this and any other applicable CTC policies, administrative regulations, rules, and procedures occur or ISP terms, local, state or federal law is violated, including, but not limited to, those governing network use, copyright, security, privacy, employment, social media, vendor access, data breach, and destruction of CTC resources and equipment. <p>Due to the nature of the internet as a global network connecting thousands of computers around the world, inappropriate materials, including those which may be defamatory, discriminatory (as it pertains to race, color, religion, national origin, gender, marital status, age, sexual orientation, political beliefs, receipt of financial aid, or disability), inaccurate, obscene, sexually explicit, lewd, vulgar, rude, harassing, violent, inflammatory, threatening, terroristic, hateful, bullying, profane, pornographic, offensive, or illegal, can be accessed through the network and electronic communications systems. Because of the nature of the technology that allows the internet to operate, the CTC cannot completely block or filter access to these resources. Accessing these and similar types of resources may be considered an unacceptable use of school resources and will result in actions explained further in the consequences for inappropriate, unauthorized and illegal use section, found in the last section of this policy and as provided in relevant CTC policies, administrative regulations, rules, and procedures.</p> <p>The CTC must publish a current version of this policy so that all users are informed of their responsibilities. A copy of this policy and <i>CIS Acknowledgement and</i></p>
