ENHANCED EMISSION INSPECTOR CERTIFICATION - E.E.I.C.

Classroom training, a CBT challenge and a proctored exam are required for a student to certify as an emissions inspector. **Before coming to class the student must purchase a training manual, a CBT challenge and on-line exam from the training provider at www.pattrainingportal.com.** Print out material and bring it with them if possible. The 8-hour training includes the CBT challenge and proctored exam. There are 50 questions per exam; the student will have 75 minutes to complete the exam. The student will be responsible for classroom training fees paid directly to the school. There is a \$40.00 re-test fee for anyone who doesn’t pass the test the first time. Students must hold valid driver’s license and must be at least 18 years old. Please bring driver’s license and proof of Penn Dot’s online registration, along with your password and ID that Penn Dot gives you when you register. **This class is 3 nights for 2 weeks.**

OFFICIAL STATE INSPECTION MECHANIC CERTIFICATION PROGRAM

▶ **Category 1** – This class covers all of the rules and regulations involved with the written and tactile exam for passenger cars and light trucks sponsored by the PA State Motor Vehicle State Inspection Process. State required equipment and regulations are discussed along with detailed demonstrations. The baseline and category test will be administered on the fourth evening of class. A score of 70% is required to proceed to the Category Tests. If the baseline test is failed, the student may retake the entire course at the cost of \$100.00. If the baseline test is failed, the student may retake the entire course at a cost of \$100.00. If the category 1 test is failed there will be a \$40.00 re-test fee. If the tactile test is failed there is a \$80.00 re-test fee. The tactile test will be scheduled individually between the instructor and the student. **Student must hold valid driver’s**

license and must be at least 18 years of age. If you let your safety Inspection Certification expire you will have to take the course all over again. Book included the first night of class. Class size limited. To add the category below, the cost is additional. **This class is 4 nights for 2 weeks plus additional night for tactile.**

SAFETY INSPECTION TOOL CLASS

This optional class is recommended for all technicians entering or re-entering the State Inspection Program. This is a hands-on class that will cover proper procedures in measurements and tools used for performing a PA safety inspection. This class will be taken before the tactile test. **6:00 – 9:00 pm, 1 Class.....COST: \$50.00**

▶ **Category 2** - Motorcycles add **\$125.00** - must have State Inspection certification. **This is a testing opportunity. No class instruction is offered with the CAT 2 certification test.** You will have to take a written test and the tactile, you will be expected to study for the test on your own time by studying the Vehicle Equipment and Inspection Regulation Book on the following website: www.dmv.state.pa.us If the tactile is failed there will be a \$50 re-test fee. If the written test is failed there will be a \$30.00 re-test fee. **Call for dates.**

▶ **Category 3** - Trucks over 17,000 lbs. add **\$250.00** - must have State Inspection certification. **This is a testing opportunity. No class instruction is offered with the CAT 3 certification test.** You will have to take a written test and the tactile, you will be expected to study for the test on your own time by studying the Vehicle Equipment and Inspection Regulation Book on the following website: www.dmv.state.pa.us If the tactile is failed there will be a \$50.00 re-test fee. If the written test is failed there will be a \$30.00 re-test fee. **Call for dates.**

▶ **Category 4 - Enhanced Vehicle Inspector Certification Test and/or Document Reviewer**
To prepare for CAT 4 go to the website www.dmv.state.pa.us The Enhanced Vehicle Safety Inspection Self-Study Training and Reference Guide must be studied before the test date. **This is a testing opportunity. No class instruction is offered with this certification test.** You will be expected to study for the test on your own time, if you are registering for the Inspector test, you must have a **valid PA State Safety Inspector License**. If you are testing for licensing as a Document Reviewer, **you do not need a PA State Safety Inspector License**. The cost for each test is **\$40.00**. **Call for dates.**
